

Reclaiming our Fisheries - forewarned is forearmed!

Fishing for Leave's John Ashworth examines the tremendous hand the UK has to play on fisheries, provided the draft Withdrawal Agreement is abandoned. We should be reasonable, but not a pushover. It is absolutely essential that we assert our whole and sole control over our own Exclusive Economic Zone (EEZ). Just as vital is that all Brexiteers understand these issues NOW so that we are not deceived into losing control of our fisheries once again.

"Every so often it happens that, as you are researching one subject, you come across an item that sets you off down a different pathway.

Reading a House of Commons debate of 31 October 1984 on Greenland's withdrawal from the then-EEC, I came across this oral question from one future Foreign Secretary to another.

MP for Livingston, Robin Cook (Foreign Secretary from 1997 until 2001) asked: "*Could the Minister explain what financial compensation the UK receives for having granted the Common Market access to British fisheries?*"

Reply from Secretary of State Foreign and Commonwealth Office, Malcolm Rifkind: "*That is a somewhat foolish question; we are dealing with the withdrawal of Greenland and the Community's entitlement – which it was anxious to maintain to fish in Greenland waters. If the Community*

wishes to fish in waters which are not part of the Community, it is right and proper that there should be some quid pro quo. The Hon. Gentleman may speculate about the implications of that for other territories that might wish to Withdraw from the Community, but such speculations are not relevant to the order."

There was nothing foolish about Robin Cook's question. When Greenland left the EEC there was no automatic entitlement for the Community to continue to fish in Greenland's waters. Greenland became entitled to exclude European fishing boats from its waters, or to charge them for the privilege of continuing to fish there under Greenland's own rules.

While Greenland is not clear-cut as a direct comparison to the UK (being classed as an Overseas Territory of Denmark), Cook was rightly getting at an important point. If you are a member of the EEC/EU, you hand your established fishing zone over to become EU waters for all other EU member states to share equally the resource within – free of charge. Whereas if you are a non-member, you get paid annually for the resource one allows the EU to take, plus access to their market. As Cook's pointed 'question' hints at, Edward Heath gained absolutely nothing for Britain by surrendering our waters to European control and plunder.

This one question leads us further.

The EU countries have a voracious appetite for fish and many marine species, and so the EU relies heavily on third country fishery agreements and other non-EU member agreements. Two important ones are Mauritania, which is due for renewal later this year, and Greenland next year.

Because of the pressure on the EU over Brexit, the EU risks finding itself short of marine resource. Will these two independent states up the stakes and demand a better deal for renewal? And more to the point, will the British government make use of the strong hand it holds on fisheries?

We should be prepared to be reasonable, but not a pushover. Fishermen in friendly EU countries such as Denmark have invested a great deal of money in the quite legitimate expectation of fishing in our waters whilst we were part of the EU, which was expected to be indefinite.

Equal value swaps would also be an immediate and simple solution, although great care must be taken as to what agreement is agreed, as we could end up being controlled by the EU, which appears from the wording of the present proposed Withdrawal Agreement to be their intention.

There is also another good reason – provision in UNCLOS (the UN Convention on the Law of the Sea) that neighbouring states could demand rights to fish our waters if we were

unable to make full use of them. Our present depleted fishing fleet could not do that at once on its own; although if the EU became difficult, the UK holds the right to lower the recommended TACs to a level at which we could. The UK has a tremendous hand to play concerning fisheries, which Mrs May surrendered in the (hopefully now dead) Withdrawal Agreement.

So there are two good reasons for not taking a fierce 'dog in the manger' attitude to our fishing waters. But it is absolutely essential that we assert our whole and sole control over our own Exclusive Economic Zone (EEZ),

which extends 200 nautical miles from our shores (or to the midpoint if neighbouring countries are less than 400 nautical miles away), just as just as other non-EU nations have done. There is nothing nationalistic or selfish about this: it is the international norm for sovereign nations.

'Territorial waters', by contrast, is an expression which applies only to waters which are within 12 miles of our coast. It is vital to be aware of the difference between territorial waters and the Exclusive Economic Zone – especially when slippery politicians are speaking on the matter. Sometimes they use the term 'territorial waters' to

deceive, and sometimes because they are ignorant of the difference.

Forewarned is forearmed! It is vital that all Brexiteers understand these issues NOW so that we are not deceived into losing control of our fisheries once again. Although there are many other issues to sort out, none are impossible as long as the UK is genuine about taking back control and leaving the EU's horrendous Common Fisheries Policy (CFP) well astern."

UK job prospects improve

Yet again despite the gloom and doom merchants like Corbyn and the pro-EU lobby, the actual facts on the United Kingdom (UK) job market shows wage growth in the UK reached an 11-year high in the year to June, and the employment rate was its joint

highest since 1971.

According to the Office for National Statistics (ONS) overall, a record high of 32.8 million people were in employment.

Wage growth rose to 3.9%, while the estimated 76.1% employment rate

was the best since comparative records began.

This was 425,000 more than a year earlier and was largely because of more people working full-time.

This includes the current level of 3.5 million EU nationals living in the UK.

What is clearly of interest from these numbers is the amount the EU will loose when the UK leaves. It also shows how control of the EU is actually in the hands of only a few of its members.

UK's influence over the EU

Much is said about remaining in the EU in order to have influence within the EU and the wider world.

However the facts speak very differently.

In 1979 out of the 410 MEP's the UK had 81 a 19.8% possible influence.

In 1986 out of 518 we had 81 a 15.6% influence.

In 1995 out of 626 we had 87 a 13.9% influence.

In 2004 out of 732 we had 78 a 10.7% influence.

In 2019 out of 751 we have 73 a

9.7% influence.

Clearly from the foregoing figures the so-called influence rate has been dropping ever since we joined and with further enlargement will only drop further. As for EU Commissioners in 1973 we had 2 by 2014 just 1, now 0.

1975 "There is no danger of a single currency", Edward Heath.

1991 (In interview with Peter Sissons) Sissons - "The single currency, the United States of Europe: was that on your mind when you took Britain in?" Heath "Of course, yes".

2000 Italy - Giuliano Amato, former Italian Prime Minister, Vice President of the European Constitutional Convention" in *La Stampa* July 13 Interview by Barbara Spinelli. "Amato said that however daring a political project might be ...it must be hidden, camouflaged. One must act "as if" in Europe. "As if" one wanted a very few things in order to obtain a great deal. "As if" nations were to remain sovereign in order to convince them to surrender their sovereignty. The Commission in Brussels, for example, must act "as if"

it were a technical organ in order to operate like a government.

He said that sovereignty lost on a national level does not pass to any new individual.

It is entrusted to a faceless entity....eventually the EU. The (European) Union is in the vanguard of this changing world.... The new entity is faceless and those in command can neither be identified nor elected. As a matter of fact the metamorphosis is already here. All we need are a few corrections here and there along with a great deal of cunning...."

This is the EU which people voted to leave. Whilst Parliament voted to respect that democratic choice, there is no doubt that a majority of MPs are Europhiles who would prefer to stay - which is why they.... are dragging their feet and playing deceitful games in their hope of continuing in their comfortable European servitude.

Self-determination

Our fight with Brussels does not end on the 31st of October. This wider conflict that Brexit represents is between sovereign nations and supranational organisations, between self-determination and central planning of the most wicked intention. In order to capitalise on our departure, we must first recognise a weakening, Brussels is tightening its grip on Europe. It is desperation which makes it ever more dangerous, secondly, we must address how we combat this agenda and provide better alternatives in a post Brexit world.

The European Union (EU) is founded on flawed principles, but since the Brexit referendum it has grown weaker and more desperate. GDP growth for Germany was 0.6% this year, and Deutsche Bank's shares are lower than they were during the 2008 financial crisis, they even had to make thousands of staff members redundant. The Euro Zone has an average 7.5% rate of unemployment, compared to the UK's 3.7%. This economic fragility is precisely why the EU has been so aggressive during Brexit negotiations and more importantly, is why they are tightening their grip on Europe.

We see this mainly in their support as early as 2015 for the 'Five Presidents Plan', that aims to work towards a Federal Europe. The recent appointment of Ursula von der Leyen, a failed German Defence Minister, and her determination to create a European Army proves a Federal Europe is still the ultimate goal. Their weakness has made them determined to prevent any other European nations take back control. They are succeeding, our inability to leave on the 29th of March

2019 and the following setbacks have crippled Eurosceptics across the continent. In France, Marine Le Pen's National Front party backtracks on a referendum of EU membership, yet still won a majority in the European elections. In Italy, the populist coalition says there will be no question of their membership, only pitiful reforms. In central Europe, hard-line Eurosceptic nations stay silent. The message is clear; Eurosceptics are afraid of the chaos that may follow a decision to leave the EU and that's exactly what the Commission and federalists want. Brussels will only see this as a win, and an excuse to pursue closer integration of the European countries against their will, depriving them of sovereignty. This desperation to succeed, and the opportunity provided through our own failure to manage Brexit will have adverse effects. It will make their consolidation of power more aggressive, binding each country to one another and stripping nation states of their independence, giving greater legislative and fiscal powers to the European Union. We see this in proposals for greater tax powers and more plans on how countries should be spending their own money, but also their expansion into the Balkans, pushing for evermore members whilst lowering the requirements to enter. After all, when a nation loses control of not only its sovereign currency but then its authority over its economy then surely it becomes a sovereign nation in name only.

This combination of economic fragility and opportunity in the eyes of Brussels will only make the conflict between sovereign nations and

supranational organisations tenuous. And it is this threat from an ideology that strips individuals of their freedom and democratic values in order to support a bureaucratic and undemocratic machine in Brussels. Much like the Soviet Union, from "Stettin in the Baltic to Trieste in the Adriatic, an iron curtain has descended across the continent."

In order to combat this, and we must combat this, we will need to present ourselves as the shining example of what can be achieved outside the bloc, through trade deals with the USA, China, India and other economic powerhouses. But we must also look directly to those countries within the EU, we must cooperate, negotiate and celebrate together, as sovereign nations in order to undermine the influence of Brussels over those countries dependent on it. It would be a stretch to suggest a cold war is brewing, but the 31st of October marks not the end of an era but the beginning of conflict between two very different viewpoints. The greatest philosophical conflict since the fall of the Berlin wall and the Soviet Union. We cannot let the European Union destroy European identity and culture by blending all into one federal state, Mrs Thatcher said in her 1988 Bruges Speech to the College of Europe "Europe will be stronger precisely because it has France as France, Spain as Spain and Britain as Britain each with its own customs and traditions. It would be folly to fit them into some sort of European identity."

Dear Sir,

May I bring to your readers' attention the valuable work that has been, and is being, undertaken, by the British Weights and Measures Association (BWMA). The association has, for many years, been waging a resolute struggle to end the EU-inspired criminalization of the use of our customary weights and measures and to resist the imposition of the alien Metric System.

The journal of the association, 'The *Yardstick*', gives details of how various BWMA members are striving to defend our use of our traditional pints, yards and pounds. I have found these accounts of their efforts enormously illuminating, for they reveal in stark, undisguised detail the mentality of the people who are administering our country. Time and again, the BWMA members make contact with local and central government officials and point out to them that it has never been made legal to replace and exclude measurements in miles and yards from public signs. Time and again, these various officials reply in a dilatory or misleading fashion. The BWMA, however, is not put off by vague, irrelevant or inaccurate replies and follows up with a well-informed explanation of current legal requirements to display both systems of measurement. Time and again, the officials then respond, if they do at all, with answers that are deceitful, truculent and arrogant.

The discourtesy and hostility expressed in these replies of officialdom do not stem just from an inward-looking bureaucratic mind-set. They tell us that those people who are running the government of our country, at all levels of administration, are following an agenda to which they obstinately cling, regardless of the legal position and regardless of the opinions and feelings of the rest of us.

This agenda is to promote the interests of the EU over those of our nation. (The decriminalization of the use of Imperial Measurements would give our exporters a huge competitive advantage in trade with the USA and awareness of this seems to be behind much of the insistence that we have to conform to the general European measuring system.) The agenda promoted by those who govern us involves the deliberate suppression of the characteristic features of our national identity, heritage and culture. The mindset and the agenda are profoundly undemocratic.

All those who wish for our country's liberation from the yoke of the EU should read 'The *Yardstick*' and learn the key lessons it reveals. It is becoming apparent that it will not be enough for us to win over politicians and fight for parliamentary majorities. It will also be necessary to confront the anti-patriotic and anti-national mentality that is entrenched inside the civil service and the other ruling institutions. We must make sure that the dominant elite learns to accept and respect the values, opinions and loyalties of the rest of the us and that they act to promote our own nation's interests with all the dedication that they have promoted, over the past forty-six years, the interests of the EU.
